Rejection: State registration of changes to information about the legal entity, 22.11.2023 16:49:24, Ahafonova O.S., Kyiv Interregional Directorate of the Ministry of Justice of Ukraine

Reason for rejection: The documents contravene the requirements of the Constitution and laws of Ukraine (Clause 3.2 of the Organisation's revised Articles of Association contravenes the provisions of Part 1 of Article 8 of the Law, as regards the determination of the age of the Organisation's members. Clause 4.1.8 of the Organisation's revised Articles of Association contravenes the provisions of Clause 3 of Part 2 of Article 21 of the Law, as regards the creation of media outlets by the Organisation. Clause 10.6 of the



Organisation's revised Articles of Association provides for the existence of Regulations within the Organisation's separate divisions, which contravenes Part 2 of Article 13 of the Law. In accordance with Part 4 of Article 105 of the Civil Code of Ukraine, the powers to manage the affairs of the legal entity are transferred to the commission for the dissolution of the legal entity (reorganisation commission, liquidation commission) or the liquidator from the moment of their appointment. Clauses 10.6 and 12.2.3 of the Organisation's revised Articles of Association contravene the aforementioned provisions of the law, as regards the terms for the liquidation commission to assume its powers. The Organisation's revised Articles of Association do not fully comply with the provisions of Part 2 of Article 98 of the Civil Code of Ukraine, since, in accordance with the provisions of the legislation, decisions of the General Meeting, in particular regarding 'the disposal of the company's property in an amount constituting fifty per cent or more of the company's property', are adopted by a majority of not less than 3/4 of the votes.).

Rejection: State registration of changes to information about the legal entity, 09.01.2024 17:20:18, Ahafonova O.S., Kyiv Interregional Directorate of the Ministry of Justice of Ukraine

Reason for rejection: The documents contravene the requirements of the Constitution and laws of Ukraine (Clause 10.6 of the Organisation's revised Articles of Association provides for the existence of Regulations within the Organisation's separate divisions, which contravenes Part 2 of Article 13 of the Law of Ukraine 'On Civil Associations' and is inconsistent with the provisions of Clause 8 of the Final and Transitional Provisions of this Law, since only local branches of all-Ukrainian (international) non-governmental organisations that operated with the status of a legal entity on the date this Law came into force retain their status as legal entities after the Law came into force, by decision of the higher governing body of the all-Ukrainian (international) non-governmental organisation.).
